Regular Meeting

December 8th, 2021

The regular meeting of the City of Easton was called to order by Mayor Bryant Stiernagle, December 8th, 2021 at 6:00PM in the Easton Community Room.

Tara and Eric Garbes were addressed and they were present to request to apply for a liquor license for Margaert's Pub as they are in the process of purchasing the pub from Eric & Rhonda Allis. Motion by Jon Rath second by Tony Stevermer to approve liquor license for the Garbes'. Motion carried.

Motion by Gayle Heise second by Tony Stevermer to accept minutes of the November 10th meeting. Motion carried.

Motion by Jon Rath second by Gayle Heise to accept financials with exception of Swehla Exc. Bill for dump grading as council felt more information on the work done was needed.. Bill was tabled until January meeting. Motion carried.

Public Works: City resident had contacted WPU regarding rusty water. Was told to let water run to clear and problem was solved. Craig Anderson has been hired by WPU. Tri City will meet Monday, December 13th. Motion by Jon Rath second by Tony Stevermer to approve New History for the demolition of the old water tower in the amount of \$7,000.00. Motion carried. A storage building was discussed regarding the storage of Easton's equipment etc. after new system is put in place.

Park & Rec: No report

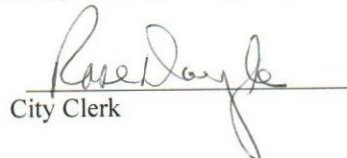

Motion by Gayle Heise second by Tony Stevermer to approve a building permit for Brian Rath to construct an addition to machine shed and for building a field driveway within the city limits. Motion carried.
